We are a rural district without city bus service and we don't run bus routes after practice, so transportation is a barrier.

Many students simply stop turning out. We don't have a way to off set that "experience gap" created by the club sports.

This spring we offered free after school gym time for basketball and volleyball. We were surprised we didn't have more students sign up.
